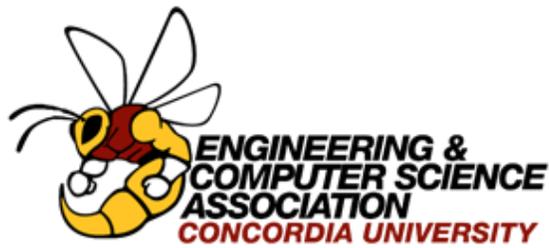

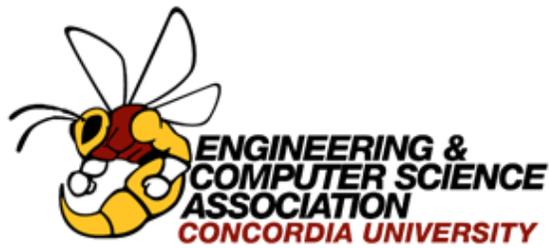

Erman: If the money is coming from the university then just give them the money.

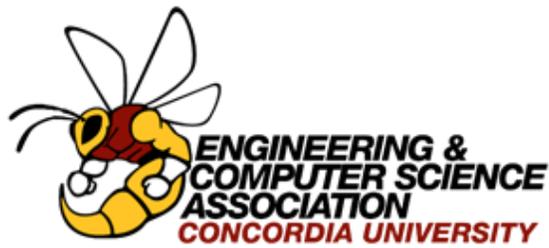

Remi: Are you asking for the opinion on the policy or motion for it?

Sierra: we won't make a motion now, we will just discuss it

Esinti: Basically any society other than GCS isn't qualified since the others don't do elections, this is why the policy isn't in motion right now

Erman: we are giving every VP around 2500\$ so I don't think it's a good idea

Seif: does every society have their own honorarium?

Sierra: no

Sabrina: I don't think societies are willing to change their election procedures just for 150\$

Esinti: it is also a way to encourage society to have an election procedure. At the same time it is better to have an open election with all engineering students. Execs ECA isn't close to what other members of the societies are putting.

Sierra: The ECA BOD has more legal responsibility because we are registered non-profit.

Erman: I don't think they will bother to change the procedure for 150\$, because it's not enough money.

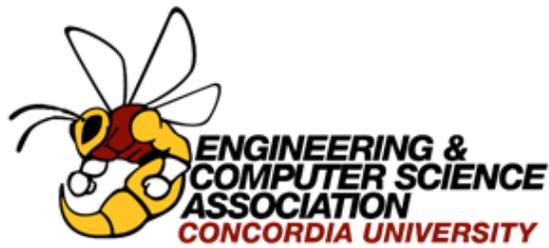
Sierra: I think this number was just thrown out at the time, we can increase it if their mandate report is very good

Esinti: We can change the procedure and requirements, for example we make them submit a mandate report that is reviewed by the BOD to see if it's enough and transfer the knowledge to the new president, we could also discuss if we should add an election procedure.

Zoe: We should remember that giving the president money isn't simple, like if they were just voted by a small group then it's not fair and they don't deserve it.

Seif: Alright, first we need to know the point of the policy? So that we know what to do after that.

Esinti: I agree with Zoe, we can do that, like we can increase the amount but also they make a mandate report because some presidents don't build as much as the others.

Elsa: So the amount we give them depends on what they did?

Remi: I don't think we can do that and that's not what was being discussed

Esinti: We can increase the amount but it depends on the effort they put in and knowledge transfer and all that. We wouldn't give them 500 dollars just because they had an election for 5 people.

Erman: If you want the BOD to decide if we give them money or not, it will be trouble. The BOD should write the criteria of what they are expecting, then based on that if they meet the criteria, we give them the money.

Seif: Yes, so if they didn't submit a good mandate report, like they didn't fit the criteria, then they won't get the money. This is something we can do in the BOD as well.

Sabrina: Will it be like if you don't submit one, you will automatically not get the money?

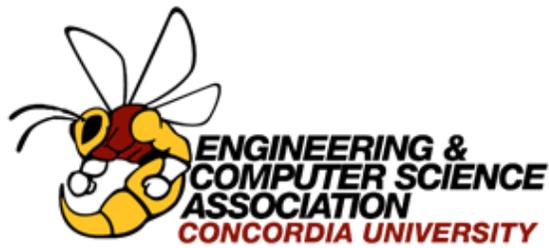
Esinti: I agree. That way we will be able to keep a good history tab on the societies, and for us we could see what events the societies organized and be more aware of what our societies do.

Erman: So the 2 criteria is to make a mandate report and have an election? That's alright with me but the job should be given at least 500\$ for people to care.

Remi: If you want to give 500 to every president then that's 6% of the budget we give to societies.

Esinti: Those 500 dollars can be used differently, for example wine and cheese is the most expensive event, they could use that there.

Erman: Are we having more budget difficulties since we have an extra society this year?

Remi: About that, at the finance summit we are trying to make a separate fee-levy for each society. So it should reach BOD at some point.

Esinti: They shouldn't be doing the job for the money, it should be a "thank you" thing. When we started we weren't given anything.

Erman: If Remi is working on individual fee-levies then it should be part of it. I want to motion to table this.

Remi: The budget for societies last year was 120k\$, at the end of the year we spent 180k\$ on societies. Right now, I say an amount that is nice is 175k\$, financially is more stable.

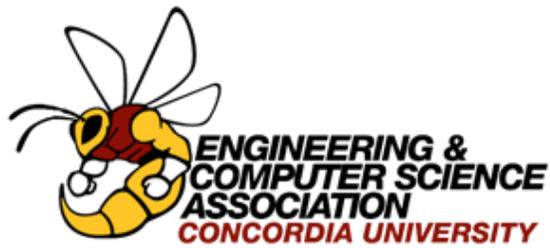
6.1 Approval of Troitsky Photoshoot budget

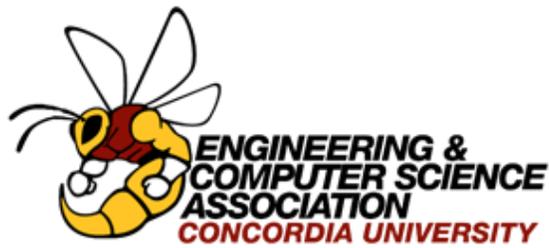

6.4 Approval of Competition Fund Policy

Esinti: We have a design team fee levy and competition that was last year. This year we are working on the policy for it to make sure our societies have access to these funds. I had a meeting with the societies to discuss how to make modifications on the DTFL in terms of timeline and procedure, as a committee we wrote the policy you can see here. The purpose of this fund is to give the societies more funds so they can have competitions with more budget, for example 10 cents per credit for students. Member associations are eligible to apply for this fund. So if they didn't have their competition earlier they can have it this year. The timeline is similar to the DTFL but delayed a bit for the committee to approve. It will start October 1st, the application will be sent by Sierra, and the email address will be the same as the DTFL.

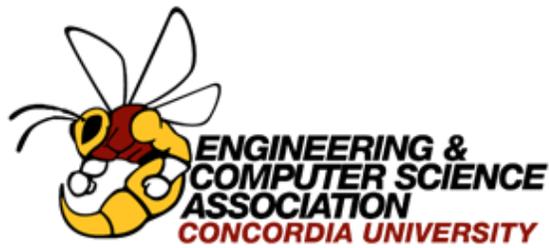

6.6 Halloween budget

Chloe: Here is an excel sheet of the costs and revenues. It should be 25k for the event. The event fee is 7.5k and then we have alcohol, etc. There should be a total of 500 people, but we are allowed 10% overbooking. We will be paying for the following bottles, and there are deals on the night as well as it is an open bar event so people will show up. For ECA we need to pay 3k from our pocket (out of budget).

Sabrina: When and where is this?

Chloe: Thursday 27th at Muzique.

Remi: If not all tickets are sold how will we deal with the loss?

Chloe: I think we should do like Beach Club, we split by ratio. Another option is selling by tier (the higher the tier the more expensive). We could discuss how much every society will spend. In this sense we can estimate how much each association owes us or just split by proportion.

Remi: Now that I am looking at this, there is no way there is a loss.

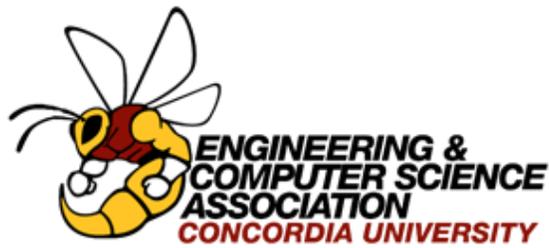
Chloe: using the tier list function, we can keep track and see who spent what.

Chloe: I also wanted to split them and make different links with passwords. I just want to remind you, I am just trying to approve the budget right now, not the way to sell it.

Sabrina: If we make different tickets and make links for them. If we post the wrong link then it will be a problem. I think it should be on one platform.

Chloe: Yes that makes sense, but that's another story.

6.8 Approval of Alcohol Policy.

Sierra: We are in-person again and we can do lizard lounges. We need to promote the safe consumption of alcohol, the policy committee has worked on the Alcohol Policy. Here is a quick rundown of the policy: we can't promote or host events without a permit, they need to take the safe serve, the staff can't drink during their shifts, you can't drink in the ECA office, B-annex, and MU-annex.

The lizard lounge section says what the societies need to do. Once the dean of office students get permission to have alcohol they then need to give it to the ECA president for notice. There should be food, drinks, and water available for the attendees. Staff need to be at the entrance and exit to make sure alcohol doesn't get out. After the events alcohol should be in storage at all times. There is a policy compliance that is expected to be agreed on.

Sabrina: Does that mean we can't drink at all at events, or just not in B-annex?

Sierra: You just can't drink at b-annex to "chill" without an event permit. Does anyone have any questions?

Erman: Isn't this part of safe service? Why are we repeating this?

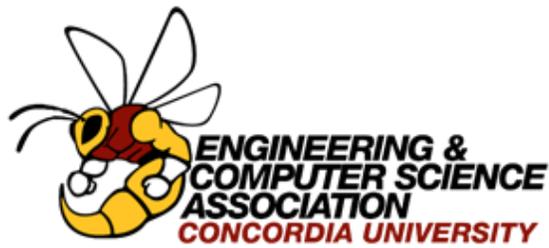
Sierra: Because there have been violations, so we need to be more strict about this.

6.9 CELC Fees and Selection

Here is a list with the delegates and their prices. This includes the transportation fees, which will total 4 delegates for 5.5k and 5 for approximately 7k. I want to ask which to approve of 4 or 5?

Sabrina: Is the round-trip per person?

Zoe: Yes, it's for going to the event and back. We did the total registration fees times the trip cost. The pre-delegate registration is basically saying the ECA will send that many delegates, we don't need to pay anything yet.

Remi: I would be more comfortable with getting a better price for the transportation cost.

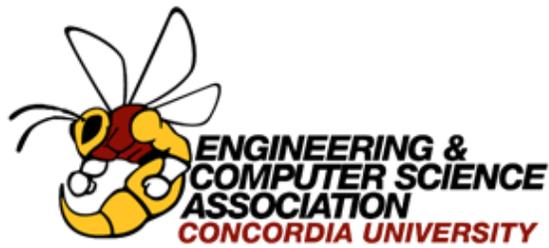
Zoe: I rounded up the average, so it's better to be under-budget than over. The registration cost includes hotel and food. I didn't have time to contact a travel agent so this is from me.

Huuy: Can the price for the transportation be 700 max?

Zoe: I can try.

Remi: Is this the same as before COVID?

Zoe: I tried to base it on that. The reason I chose 800 is because it's the highest I saw, so I put it to be safe. The trip will be from January 2nd to January 8th, the price includes transportation and food.

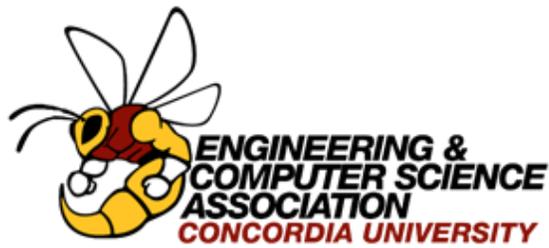

Seif: why specifically was the transportation presented this time

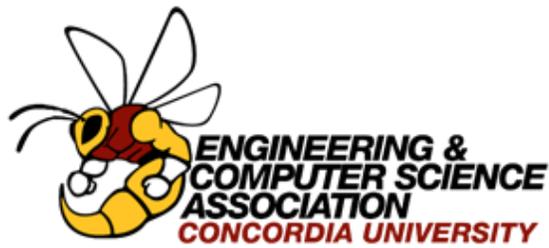

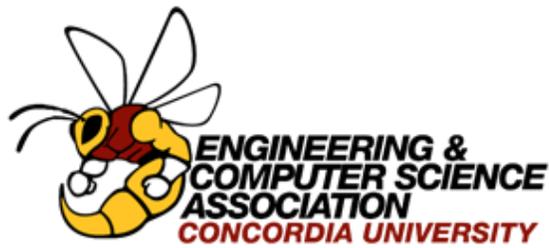
Elsa: Since these people from the societies agreed to be part of the DTFC I motion to approve them.

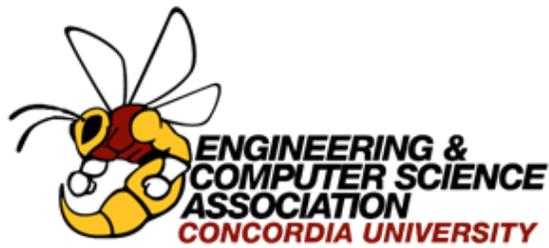
Tharushi Rathnayaka: If you didn't know, we are making a google internship conference if you want to come! There is also the Iron Ring.
