## 4.1 CSME Budget Review

## 5.3 Bylaw amendments

Seif: So By-law change let's take it from the top. So we start with the definitions we added a section for directors, so in the By-laws we refer to directors as the BOD so everyone in the board of directors, but normally we use directors to refer to each VP's sub-director so I just added a definition to make it more clear. So here it says that the BOD once every month but I changed it to at least once every month. In its current wording it makes it sound like we can't have multiple meetings in the same month which sometimes happens. Then in the second section it says the president or 3 directors can call meeting of the BOD, but what we usually do is we wait for three points instead of three directors so the wording was changed to a meeting can be called by the president with no minimum number of points on the agenda or by the Chairperson if at least 3 points are added to the agenda.
